Core Safeguarding Learning Pathways

Delivery Format	Completed Online through Safeguarding Training Portal. Approximate completion time is 1hr 15 minutes. Questions to complete throughout the pathway. Completed by attending 2 x 90 minute Zoom or face-to-face sessions with pre-session activities and a reflective evaluation exercise. Required Church Officer Completion	Required for all Church Officers – Anyone undertaking a role on behalf of the Church, ordained or lay, paid or volunteer. Required for anyone going on to complete any other safeguarding learning pathway.	Required for: -Anyone holding the Bishop's licence, commission, authorisation or permission. -Anyone in a role which involves work with children or vulnerable adults. -Churchwardens -Pre-Ordination or license students, prior to BAP or selection panel. -Vergers -PCC Members / Lay Chapter Members. -Staff at TEIs with student facing roles. -Members of the Diocesan Safeguarding Advisory Panel. -Anyone going on to complete any other safeguarding learning pathway.	Required for: -Anyone holding the Bishop's licence, commission or authorisation. -Non-executive members of Chapter. -Parish Safeguarding Officers / Safeguarding Leads in all Church bodies. -Teaching staff at TEIs who deliver the Leadership Pathway. -Anyone that you consider within your local context who significantly influences the culture of the Church body. This might include lay ministry staff employed by the PCC or churchwardens during a vacancy.	Required for anyone holding PtO, ordained or lay, as an alternative to the Leadership Pathway. If someone with PtO significantly influences the culture of the Church body then they should complete Leadership and not the PtO Pathway.

Completed by attending 2 hr 15 minute Zoom session and pre-session activities. Will be available as online module, expected to be launched in 2021.
Required Church Officer Completion	Required for anyone taking on the role of Parish Safeguarding Officer. Existing Parish Safeguarding Officers are welcome to attend if they would find this helpful.	Required for: -Line managers and anyone involved in the recruitment of Church Officers who have substantial contact with children or vulnerable adults (employees, elected members, volunteers). -Incumbents. -DBS Recruiters and Verifiers. -Parish Safeguarding Officers / Safeguarding Leads in all Church Bodies. -Ordinands during IME1.	Required for: -Anyone holding the Bishop's licence, commission, authorisation or permission. -Bishops Visitors / Pastoral Visitors. -Parish Safeguarding Officers / Safeguarding Leads in all Church Bodies. -Ordinands during IME1. -Staff at TEIs with student facing roles. -Members of the Diocesan Safeguarding Advisory Panel.

The table below does not include an exhaustive list of roles within the Diocese but gives an indicator of the safeguarding learning pathways required for Church Officers. For some pathways e.g. Safer Recruitment & People Management, the Pathway should be completed by the Church Officer if they are involved in safer recruitment and people management.
