November DAC minute:

This case, being the first application for a visible solar panel array on a listed church in this Diocese, is also the first application for solar panels the DAC has dealt with in around eight years. The DAC recognised that the landscape has changed considerably in the interim, and improving technological capability and the commitment by the C of E to achieving Net Zero means that the DAC is likely to see many more such applications. The DAC acknowledged that it is also learning lessons from installations that have been in place for ten years or more. Alongside the need to balance the visual harm of visible arrays on listed churches with the public benefit offered by such installations, this intensifies the complexity and nuance of each case. Bearing this in mind, the committee's feedback was given in principle, with the caveat that much more detailed designs for both the solar panels (including associated works such as battery storage) and the heating system would be needed for the formal application, which would need to return to the full DAC for consideration.

As part of this detail, provision of appropriate calculations for both the final heating system design and the power generation from the solar panels (separately for each roof in question) would be needed allow the DAC to assess the overall picture and provide assurance of the viability of the solar panels and the benefit they would offer. Subject to design and calculations which fully evidence that solar panels *are* viable in terms of efficiency, the committee was content to agree the principle of arrays on the south chancel roof and the south roof of the north aisle. This would be the committee's first preference for the layout of panels owing to the reduced visibility of the chancel roof and the near total lack of visibility of the north aisle roof from the ground or surrounding areas.

It was recognised that an array on one roof alone may not generate enough electricity to be worthwhile. It was also acknowledged that an array on the north aisle may not be worthwhile given the extent to which it is obscured from direct sunlight by the nave roof. If it were to be demonstrated that an array here is not worth pursuing, then the committee considered that the organ chamber roof would be an acceptable location for solar panels, in addition to an array on the chancel roof. The DAC agreed that it was sensible that the nave roof had already been discounted on grounds of visibility, as it would have agreed with the planners in this respect. Further details are awaited in due course.

November DAC minute:

Concerns were raised over the positioning of the WC in option 6 and its potential impact on the wall paintings in this area. It was understood that the consecration crosses visible on the west, south and north wall are believed to date from the 12C consecration of the church. It was pointed out that it was highly likely there were also wall paintings under the paint which had not yet been exposed. The impact on wall paintings will be something that will be important to Historic England as well. The DAC felt that any services and fixings should be specially designed to ensure minimal damage to the walls. To achieve this, it was suggested that the WC enclosure could be positioned at 90 degrees to its current configuration and/or at a distance from the church walls.

The committee understood that the church did a lot of work with children and the elderly and so internal access to a WC is important. Though they had communicated concerns regarding the wall paintings, they agreed nonetheless that the success of a new WC enclosure in the nave will come down to its design detail. Therefore, in addition to other options, the DAC encouraged the parish to develop drawings for a WC in the southwest corner of the nave with their architect. 3D visuals and elevations will be vital in demonstrating the impact of the new WC enclosure on the character and volume of the church.

The committee agreed that the proposed location for the organ was not sensible, and access to the instrument must be reconsidered as part of the current application. The question was raised as to whether a wheelchair could comfortably fit between the west end pews and font to access the kitchen and new WC. If the parish choose to progress with a WC at the west end of the church, it will have to be demonstrated that a wheelchair could easily pass by the font.

The committee heard that the parish had considered locating the WC outside; however, the parish had felt that there was not a practical site on which to place a WC without causing considerable impracticalities, especially for families with children and the elderly. The committee felt that more had to be done to demonstrate an external stand-alone WC wasn't a viable option. To demonstrate this, the committee requested that the architect draws up the best possible option for an outside WC, so the full impracticalities of accessing an outside WC can be effectively evaluated and weighed against the impact of the finalised internal options.

The DAC agreed that there was no obvious part of the church which could easily be extended without potentially causing harm to the church. However, it was noted that the architect had not considered extending the south porch on its south side. With this option, the south porch could be used as a corridor to the WC, giving it more of a purpose and enabling the WC to be accessed internally without causing disruption to the nave and its wall paintings. It would also enable the parish to use the southwest corner as a dedicated children's space/meeting space if they wish to. Like the other options, its success would very much come down to the design detail. There is also the consideration of headstones which may lie in the area. It was also highlighted that the architect had not considered utilizing the vestry to accommodate a WC and providing external access.

To summarise, the DAC were encouraging of the parish's plan to introduce an accessible WC and felt their need was very evident. However, it was felt that additional options needed exploration to ensure the final design provides the greatest benefit for the church with the minimal impact on historic fabric.

The parish's proposal to improve accessible access from the north porch was also encouraged and the DAC asked for detailed design drawings for this aspect of the plans.

November DAC minute:

The DAC commended the aims of the project and was entirely supportive of the proposals for the access improvement, provision of the WC, servery, the relocation of the vestry. The contingency plan to revert to a cess pit if the trench arch drainage option proves untenable was considered sensible. The external elevation of the proposed south door was considered fine, but it was agreed that the internal elevation should have traditional horizontal ledges and that the historic draw-bar should be retained (even if not in use). While the committee agreed that it is entirely sensible to raise the floor internally, concerns were voiced relating to the damp issues with the existing floor, and the proposed infilling of the floor with concrete, with a breathable limecrete perimeter. It was considered that, at this point, not enough is known about the causes of the areas of severe localised damp in the church, and in order to agree the proposed floor works, and the committee advised that some targeted test holes in the areas worst affected be excavated (subject to faculty consent), since it was considered that this would be essential in ascertaining what factors play a part in the high moisture levels- and informing the solution. While it was acknowledged that the water table is guite high here, it seems odd that patches of the floor are particularly damp while other areas don't seem very affected at all. It might be that the old vents were an attempt to alleviate damp previously. Either way, a broader understanding of the factors involved would undoubtedly be helpful in agreeing the best way forward for raising the floor. Regarding the proposed use of concrete, this was an issue on which there was not a consensus amongst the DAC's architect members, with concerns voiced about the risk of moisture being driven up the walls and columns by the presence of the largely irreversible concrete floor and DPM proposed. One suggestion was that the existing floor could be excavated to provide the depth for the build-up limecrete would require, if the floor could not be raised higher (though this would look odd if the chancel were lower than the nave). Others were concerned that excavating could prove problematic in terms of the likely cost and the loss of the historic floor. While the subcommittee who attended the visit agreed that careful thought had been given to a solution, noting that it had been successfully utilised at Great Kimble, with the recognition that each situation is likely to be different, it was agreed that more in the way of a written justification (in addition to the investigations as to the causes of the damp) ought to be produced, to explain how and why this methodology has been arrived at, and which alternatives have or could be considered. Once investigation has taken place and the floor works have been agreed by the subcommittee, a Recommend Notification of Advice could be issued, subject to the usual provisos concerning bats, CDM legislation, and archaeology. Prior to work starting, a stone sample for the floor ought to be agreed with the DAC stonemasonry advisor.

November 2023 Minute:

The DAC resolved to give an in principle recommendation to enable the parish to develop the proposals, with the detailed design to be delegated to the sub-committee. The preferred option was agreed to be option 1, defaulting to option 2 if the proposal cannot be implemented due to not being compliant with building regulations or if compliance results in further significant harm to the fabric or considerable expense to the parish. The parish are expected to provide evidence to show that option 1 is not practically achievable before commencing detailed design on option 2.

The DAC agreed that should option 2 become the only viable option that the option which allows 1100mm clear space between north the tower arch column and the new screen is preferable to reduce the risk of further harm to the Medieval graffiti.

The committee expressed significant concern regarding the location of the proposals to the Medieval Swaddled infant graffiti. The parish must provide conservation reports on the whole tower columns (including the swaddled infant graffiti and the capitals) to understand the current condition, conservation measures and future protection required. Conservation and protection measures must be included within the scope of works of the faculty application.

November 2023 minute:

The committee heard that the parish had commissioned an energy audit and had explored a few heating options with the supplier Herschel. However, the DAC felt that the latest proposal submitted from the parish did not tally up with the advice given in the energy audit. It was noted that the option of infrared wall heaters was not considered in the report, therefore, it was difficult to comprehend their potential suitability. Whilst the report does refer to overhead infrared heaters, such as the Halo chandeliers, it recommends that they are used as a supplementary heating source.

It was also noted that the Halo Horizon heaters had not been trialed sufficiently enough to ascertain their success in other churches. The Herschel website does not feature case studies or photos of the Halo Horizon wall heaters in other churches. The webpage for the Halo Horizon wall heater features a mock up image of Compton Church under which the description reads, 'Halo Horizon installed in church'. Whilst this does not necessarily mean that the wall heaters would not be appropriate, it does indicate that their installation would be more of a risk for the parish as the heaters have not been trialed to the extent that their impact can be understood and demonstrated.

The DAC agreed that there was no evidential data to justify the quantity of wall heaters proposed. They had concerns about the number of heaters proposed owing to the considerable aesthetic impact this had on the church interior. Instead, they encouraged the parish to opt for a system in which each individual heating outlet was more efficient and effective, resulting in fewer numbers of heaters overall.

The committee felt that the Herschel Malibu heater was completely unsuitable as it was a patio heater. The nature of the heater being floor standing gave great potential for accidents. They also had concerns that it wouldn't produce sufficient heat to cover the rest of the chancel.

The DAC encouraged the parish to re-look at the option of Halo chandeliers as it was felt their appearance would have less of an impact on the interior of the church than the wall heaters. Furthermore, the Halo Chandeliers would be able to be positioned more centrally, meaning a more even spread of heat in the pews.

The nature of overhead infrared heating means that the legs and feet of those on the pews are left cold. Therefore, the DAC asked that the parish explore the option of fitting a portion of pews with under pew heaters, or alternatively, fitting under pew heaters via a plug and socket arrangement allowing the pews to be moved as and when is necessary.

The DAC were also conscious that the parish had only researched heating solutions from one supplier, which somewhat limited their options. They encouraged the parish to speak to Solray, who installed the radiant heat panels at St Mary's Church, Chalgrove, to ascertain whether a flat panel heater would work well in the church. Whilst the committee understood that the parish were keen to install the heaters as soon as possible, it is important that the parish explore a range of options to ensure that their final proposal is one that best suits the needs and fabric of the church.

It was resolved that the review of the finalised proposal would be delegated to a specialist sub-committee of the DAC.

November 2023 minute:

The DAC resolved that a Recommend NOA is issued for the installation of the new power supply and consumer unit to the southwest corner of the north aisle, excluding the socket outlets, subject to the following provisos:

- An archaeological watching brief for the excavations in the churchyard and cable route into the aisle to be submitted to and approved by the DAC subcommittee in advance of works commencing on site.
- A simplified design for electric cupboard to be submitted to and agreed by the DAC subcommittee.
- All fixings to be non-ferrous and into the stonework joints.
- Guidelines on electric installations to be followed at <u>Electrical-guidelines-DAC-guidance-note.pdf</u>.

The DAC encouraged the parish to consider upgrading the incoming electric supply to three-phase at the same time.

Should the parish wish to proceed with an application to place the consumer unit the tower, then the DAC resolved to issue a Not Recommend NOA for the proposals based on the harm which would result from drilling through the Saxon masonry to feed the cables into the main body of the church.

The DAC did not find that the need for the proposed level of small power provision (socket outlets) had been clearly demonstrated in the documentation and resolved that a Not Recommend NOA be issued for the proposed socket outlets. The DAC encouraged the parish to work with an M&E consultant experienced in lighting historic buildings to develop a replacement lighting scheme alongside proposals for a reduced number of socket outlets for small power in the church. It was agreed that a suitable compromise might be something along the lines of 9 socket outlets – 4 in the north aisle, 2 at the east end of the nave/chancel, 2 in the south aisle with 1 in the tower.
