

Marriage Surrogates

From 1 July 2021 only British, Irish or those foreign nationals from countries in the European Economic Area (EEA) and who have EU Settled or Pre-Settled Status are classed as 'relevant nationals' under the EU Settlement Scheme (EUSS). Therefore, if both members of the couple are relevant nationals, they may be married by Common Licence. (Please see our separate note about Common Licence applications for further details.)

Marriage Surrogates

Marriage Surrogates deal with Common Licence applications for marriages where, for one reason or another, banns are not appropriate (for example, one or both of the couple are living overseas; or banns have not been read in the correct parish(es) due to oversight or error; or there are pastoral reasons for not calling banns).
